1. Number of bills reviewed: 31

  - a. SB 220 – Human Rights Act and real estate transactions
  - b. SB 1378 – Jury Act – prohibits discrimination because of sexual orientation
  - c. HB 834 – Equal Pay Act of 2003 and past salary information
