GENERAL ADMINISTRATIVE ORDER

In light of Cook County Cir. Ct. G.A.O. 2020-01 (amended May 28, 2020),

IT IS HEREBY ORDERED THAT:

1. All Emergency and Interim Orders of Protection currently scheduled to return or expire on June 1, 2020, through and including July 2, 2020, are hereby extended, rescheduled and continued as follows:

- Cases returning June 1, 2020 are hereby extended and continued to July 6, 2020.
- Cases returning June 2, 2020 are hereby extended and continued to July 7, 2020.
- Cases returning June 3, 2020 are hereby extended and continued to July 8, 2020.
- Cases returning June 4, 2020 are hereby extended and continued to July 9, 2020.
- Cases returning June 5, 2020 are hereby extended and continued to July 10, 2020.
- Cases returning June 8, 2020 are hereby extended and continued to July 13, 2020.
- Cases returning June 9, 2020 are hereby extended and continued to July 14, 2020.
- Cases returning June 10, 2020 are hereby extended and continued to July 15, 2020.
- Cases returning June 11, 2020 are hereby extended and continued to July 16, 2020.
- Cases returning June 12, 2020 are hereby extended and continued to July 17, 2020.
- Cases returning June 15, 2020 are hereby extended and continued to July 20, 2020.
- Cases returning June 16, 2020 are hereby extended and continued to July 21, 2020.
- Cases returning June 17, 2020 are hereby extended and continued to July 22, 2020.
- Cases returning June 18, 2020 are hereby extended and continued to July 23, 2020.
- Cases returning June 19, 2020 are hereby extended and continued to July 24, 2020.
- Cases returning June 22, 2020 are hereby extended and continued to July 27, 2020.
- Cases returning June 23, 2020 are hereby extended and continued to July 28, 2020.
- Cases returning June 24, 2020 are hereby extended and continued to July 29, 2020.
- Cases returning June 25, 2020 are hereby extended and continued to July 30, 2020.
- Cases returning June 26, 2020 are hereby extended and continued to July 31, 2020.
- Cases returning June 29, 2020 are hereby extended and continued to August 3, 2020.
- Cases returning June 30, 2020 are hereby extended and continued to August 4, 2020.
- Cases returning July 1, 2020 are hereby extended and continued to August 5, 2020.
- Cases returning July 2, 2020 are hereby extended and continued to August 6, 2020.

2. The prior General Administrative Order (G.A.O. 2020 P 03 and 2020 P 06) regarding the extension of these Orders of Protection is still in effect for the dates outlined therein. The dates that those cases were extended to is further extended as referenced above;

3. Nothing in this section shall be interpreted to limit the discretion of a judge to further reschedule an Emergency or Interim Order of Protection;

4. All such cases shall be returnable at the currently scheduled return time on the rescheduled return date;

5. The circuit clerk shall docket the above continuances in the official records of the cases affected and transmit the information necessary for entry in the LEADS system to the sheriff for that purpose;

6. This Order shall apply to all Emergency and Interim Orders of Protection returnable or set for the Probate Division at the Daley Center, 50 W. Washington, Chicago, Illinois; and
