

# AUTOPAY DUES INSTALLMENT PAYMENT PLAN



Using your major credit card or/an automatic withdrawal from your checking/savings account, you can set up automatic monthly, quarterly, semi-annual, or annual dues payments—and forget about it.

## HOW IT WORKS
