# 1. POSITION TITLE AND LOCATION:

Judge Advocate/Legal Advisor 183d Air Component Operations Squadron Springfield, Illinois

Major (O-4) or Lt Col (O-5)

# 3. **QUALIFICATION**:

- a. Professional Qualifications:
- Possess AFSC 51J3 or other service equivalent
- Licensed in good standing to practice law in state or territory
- Security Clearance-TS (preferred but not required) Possess a Secret Security Clearance
- Compliance with all training requirements of AFPD 51-8 and AFI 51-801 or respective service equivalent
- b. Other Qualifications:
- Knowledge of Air Force Civil and Operations Law domains
- Experience with the responsibilities associated with Air Force Legal Office operations
- Outstanding written and oral communications skills
- Must meet the Air Force or service Fitness Standard with a current passing fitness test

#### 4. RESPONSIBILITIES:

- a. This position is a traditional part-time open to any Captain or Major eligible to transfer to the Illinois National Guard. This position serves as the Judge Advocate/Legal Advisor to the Commander of the Air Component Operations Squadron.
- b. Other responsibilities as directed by the Staff Judge Advocate and the Wing Commander.

Exhibits leadership, initiative/responsibility, teamwork, integrity and trust. Strong emphasis on superior communication skills and independent organizational skills.

#### 6. APPOINTMENT:

- b. Member will attend Regularly Scheduled Drills and 15 Annual Training days. Telecommute work is authorized and supervised by the Squadron Commander and/or Wing Staff Judge Advocate.
