The successful candidate will manage the Illinois EPA's Division of Legal Counsel's Bureau of Air Enforcement Unit ("BOA Enforcement Unit") as it provides legal counsel to the Illinois EPA's Bureau of Air ("BOA"). This individual will direct attorneys in the BOA Enforcement Unit as they develop and oversee enforcement actions on behalf of BOA and provides legal counsel to BOA on permitting actions and permits. The successful candidate will manage attorneys in the BOA Enforcement Unit as they work with BOA staff, attorneys with the Illinois Office of the Attorney General and other governmental entities, and regulated entities to ensure compliance with the Act and associated regulation, and in the review of permits and permit applications. This individual will provide legal counsel to BOA and Illinois EPA management on a variety of air pollution control issues. We invite all qualified candidates to apply.
