AGREED FINAL JUDGMENT OF CONVICTION

THIS CAUSE COMING TO BE HEARD on the agreement of all parties to this cause to enter an Agreed Final Judgment Order, the parties having reported to the Court that they have settled, compromised, adjusted, and adjourned all matters and issues between them pertaining to the above entitled cause; and the parties having further reported to the Court that they have agreed to and consent to be bound by the terms of the agreement hereinafter set forth; and the Court being fully advised in the premises:

NOW THEREFORE, UPON AGREEMENT OF THE PARTIES HERETO, THE COURT FINDS AND ORDERS AS FOLLOWS:

1. That Respondent, Marc Erwin Levine, is hereby found to be guilty of minor indirect criminal contempt of court for engaging in the unauthorized practice of law after being disbarred by the Illinois Supreme Court on January 12, 2007. Specifically, this court finds that after January 12, 2007, Respondent Levine engaged in the unauthorized practice of law by holding himself out to be an attorney, advising clients, and corresponding with opposing counsel in the following matters:

- A. The purchase of property at 1427 Fowler Road in Evanston, IL by Brian and Patricia Steiglitz.
- B. The sale of property at 1237 Southwind Road in Northbrook, IL by Harriet Goldberg, as trustee of the Harriet Edythe Schwartz Goldberg Trust.
- C. The purchase of property at 9 Porter School Road in Barrington Hills, IL by Patrick McKeVitt.
- D. The sale of property at 6246 N. Magnolia in Chicago, IL from Lori Ray to Richard Sypniewski.
- E. The sale of property at 1515 N. Wells Street, Unit 4B, in Chicago, IL from Jaime and Keith Moran to Jean Pierre Degembe.
- F. The sale of property at 16 Oak Street in Barrington, IL from Walter Smith to Richard Catalano.
- G. The sale of property at 4620 Magnolia Street #4S, in Chicago, IL from Christopher Conrad to Daniel A. Lira & Michael J. O'Gara.

- H. The sale of property at 1016 N. Columbian, in Oak Park, IL from Drew and Jennifer Medland to Carmen Solorzano.
- I. The sale of property at 2207 Oak, in Northbrook, IL from Frank and Vicki Kastory to R. Rubens Family Limited Partnership.
- J. The sale of property at 2700 N. Halstead Street # 305, in Chicago, IL from Aaron Costa to Margaret Ellen Jessopp.

- O. The sale of property at 24254 Shady Oaks Trail, in Chicago, IL from Mali Huang to Danny Huang.
- P. The sale of property at 728 W. Jackson #317 & C27, in Chicago, IL from Alison Ruddy to David Kim.
- Q. The sale of property at 836 W. Village Court, in Chicago, IL from Ryan Phasouk to Patrick and Margaret Henry.
- R. The sale of property at 6054-58 West North Avenue, in Chicago, IL from North Shore Holdings, Ltd. to Orlando Nunez.
- S. The purchase of property at 1515 N. Wells Street, Parking Space P25, in Chicago, IL by Glen Parale Barcinas

2. Respondent is hereby sentenced to six months of non-reporting probation, a fine of \$500, and six months incarceration, with the period of incarceration stayed, pending his payment of fines, and his refraining from engaging in any additional acts of unauthorized practice of law.

3. That no appeals shall be taken from this Agreed Final Judgment Order.

5. That this Court reserves and retains jurisdiction over the above-entitled action for the purpose of permitting the parties to this Agreed Final Judgment Order to apply to this Court for such further orders and direction as may be necessary for the enforcement of this Agreed Final Judgment Order.
