The Section Council reviews proposed legislation that may affect their members' practice area. Highlights of the most recent legislative session include:

1. Number of bills reviewed: 15
2. Significant legislation:
 - a. SB 1610 – Judicial admonishment in sentencing for non-citizens
 - b. HB 836 – appointment of guardian or standby guardian for “administrative separation” by immigration enforcement
 - c. SB 1290 – Immigrant Tenant Protection Act
