## Section on Local Government Law

### **Legislation**

The Section Council reviews proposed legislation that may affect their members' practice area. Highlights of the most recent legislative session include:

- 1. Number of bills reviewed: 220
- 2. Significant legislation:
  - a. SB 1152 Municipal and county administrative adjudication for violations recorded by automated systems
  - b. HB 2124 Open Meetings Act exceptions
  - c. HB 3146 Open Meetings Act and FOIA definition of "public body"
